#### **GROUND BREAKING OF SUAI FUEL STATION & GASOIL STORAGE IN SUAI**

Ground Breaking of Suai Fuel Station & Gasoil Storage in Suai

The National Oil Company (TIMOR GAP) through Refinery and Petroleum Service Unit (RPSU) conducted the Ground Breaking for the Suai Fuel Station & Gasoil Storage in Suai with Cultural Ceremony by the traditional local authorities (Lian Nain). The project located at Camanasa, Suai, Covalima District (Southern Coast of Timor-Leste)is scheduled for 5 months, started from August to December 2015.



The location and project design of the Fuel Station and Gasoil Storage project were approved by Autoridade Nacional do Petroleo (ANP) Downstream in accordance with Regulation No. 1/2013 on Construction and Operation of Fuel Filling Station to start construction.

The Ground Breaking ceremony on July 31<sup>st</sup> counted with the participation of around 100 participants, including the President of TIMORGAP, Mr. Francisco Monteiro and its Directors, the Director of Downstream of National Authority of Petroleum (ANP) Mr. Nelson de Jesus, the Administrator of Posto Administration, members of PNTL (National Police), other local leaders and the Contractor.

One of the requirement to this project is the Local Content Development where the Contractor (Winner of the bidding) is required to procure services, equipment and consumables locally from Suai / Timor-Leste. Therefore it was established a joint venture between a local Contractor, Glory Enterprise Lda and the International Contractor PT. Saka Semesta from Indonesia that was the winner of the bid.

The Malaysian Embassy in Timor-Leste in collaboration with the National Oil & Gas Company of Timor-Leste, TIMOR GAP, E.P. organized a three days business programme between a Malaysian business delegation and Timorese companies regarding the business opportunity in the oil and gas sector of Timor-Leste.

A total of 8 Malaysian companies involved in oil & gas products and services got the opportunity to present their companies and participatein a roundtable discussion with TIMOR GAP, Timor-Leste Government Agencies, including ANP (National Petroleum Authority) and AEI (Specialized Investment Agency in order to analyze potential business and investment opportunities on the oil & gas sector and others potential sectors like tourism industry.

Coordinated by the Trade Office of Malaysia in Jakarta (MATRADE), the Malaysian companies visit aimed to examine in detail the aspects and opportunities of the Tasi Mane project in the south of Timor-Leste especially now that the Suai Supply Base project is under construction since the South Korea's Hyundai Engineering Construction was awarded with the project of US\$719.21 million, which is part of Tasi Mane mega project on the southern coast of Timor-Leste.

Meetings have been coordinated with Timorese entities from the different areas that involved the private sector and governmental agencies. One component of the project that currently offers more opportunities is the construction

of the Suai Supply Base, which is essential for oil exploration activities in the Timor Sea.

"We know the potential of opportunities in this country and I encourage the dialogue to help in terms that you will help us to maximize the value of our resources"- (Minister of Petroleum and Mineral Resources, H.E. Alfredo Pires mentioned it during his speech)

#### THE 43RD JOINT COMMISSION & SUNRISE COMMISSION MEETINGS



The 43<sup>rd</sup> Joint Commission & Sunrise Commission meeting were held in Caims (Australia) on 12<sup>th</sup>, 13<sup>th</sup> and 14<sup>th</sup> of August 2015 and TIMOR GAP participated as part of Timor-Leste Commission.

The importance of Greater Sunrise for Timor-Leste is of significance as this gas field founded in the early 1970's will be piped to its onshore and an LNG export plant is to be built in Beaço, as one of the Tasi Mane projects. However Woodside on the other hand prefers to have it processed offshore by using a novel technology called Floating LNG (FLNG).

These existence of petroleum deposits which extend across the eastern boundary of the Joint Petroleum Development Area (JPDA) being known as Sunrise and Troubadour deposits, are collectively known as Greater Sunrise.

Timor-Leste decision was supported by engineering studies that the gas from Greater Sunrise will be piped to its onshore and an LNG export plant is to be built in Beaço. Therefore the Timor-Leste Delegation formed by several members, including the President & CEO of TIMOR GAP, Mr. Francisco Monteiro and his team, met with the Australian Delegation in order to keep up with the progress regarding the Joint Commission and Greater Sunrise Commission.
