TIMOR GAP HELD AN INTERNAL AUDITOR TRAINING FOR ISO 9001, ISO 14001, AND OHSAS 18001

On the 1st to 3rd of July, QHSE's Unit held an In-House Training with respect to "INTERNAL AUDITOR TRAINING ISO 9001, ISO14001, and OHSAS 18001" delivered by Mr. Capt. Naveen S. Singhal from Singapore.

The syllabus of Internal Auditor Training consists of:

- ISO and Standards
- Eight (8) Management Principles
- ISO 9001 QMS Requirements
- ISO 14001 EMS Requirements
- QHSAS 18001 Requirements
- Internal Audit Procedures and Requirements
- Internal Audit Case Study
- Reasons for Success / Failure of ISO MS Standards
- Assessment

The training was essentially based on TIMOR GAP's necessities, in terms of the establishment of the QHSE Management System and its implementation in consistence with the international best practices, namely ISO 9001, ISO14001 and OHSAS 18001.

Subsequently, the six weeks consultancy Service provided by Mr. Awinash Dulip, commenced on the 25th of May 2015 and finished on the 4th of July 2015. The consultancy service was essentially about review and verification of the QHSE MS prior to the endorsement and approval by BOD. In the meantime, took place a 3 days In-House Internal Auditor Training ISO 9001, ISO 14001, and ISO 18001 by Capt. Naveen S. Singhal with the purpose to enhance knowledge and increase the effectiveness of the QHSE MS implementation.



It is important to understand that OHSAS 18001 (Occupational Health & Safety Management System) was developed to be compatible with the ISO 9001 (Quality) and ISO 14001 (Environmental) management systems standards for easier integration of quality, environmental and occupational health & safety management systems by organizations. OHSAS 18001 outlines requirements for an occupational health and safety (OH&S) management system, to enable an organization to control its OH&S risks and improve its performance. On August 5th, TIMOR GAP held a Pre-Bid meeting in regard the public tender for "Environmental Impact Assessment (EIA) Study for Betano Refinery Project".

Director of QHSE unit, Mr. Rony da Costa chaired the meeting with the presence of several consultants. The presentation on the overall tender process was delivered on this occasion in two parts of which Mr. Domingos Freitas (Procurement Manager) presented on commercial side and Mr. Roberto Belo (Process Engineer) who presented on the technical side.

TIMOR GAP master plan in Betano area is to develop the petrochemical complex therefore, the Environment Impact Assessment (EIA) study shall be conducted on these projects as part of the requirement of the Government Decree Law No. 5/2011 on "Environmental Licensing".

On July 7th a presentation was held by the QHSE's Unit, with the presence of the President & CEO, Mr. Francisco Monteiro and all Units Directors and Managers. The aim was to disseminate the information with respect to the QHSE Management System (MS) or called Integrated Management System (IMS), which will be adopted by TG and later on implemented.

The presentation was delivered by QHSE Director, Mr. Rony Joel da Costa and TIMOR GAP's Consultant Mr. Awinash Dulip, from India who is responsible for the revision of IMS. The IMS is based on three different standards: ISO 9001 on Quality Management System, ISO 14001 on Environmental Management System and OHSAS 18001 on Occupational Health and Safety Management System. On July 29th, the IMS was approved by Board of Directors consisting of 55 procedures including the IMS Manual and 7 guidelines. QHSE Unit will do the campaign to all Units and Employees of TIMOR GAP for implementation of IMS and for certification purpose.
