Safety induction 3. Equipment commissioning	The timeline for this permitting process is contingent upon the quality of documentation supplied by the successful Bidder and the condition of the equipment. In business as usual this should run quickly and should not create any constraints on the schedule of the works. Bidders may make their own assumptions based in their experience in similar works, however it is crucial to note that this timeframe must be encompassed within the overall project duration of 5 months.
