A. SUMMARY

B. VACANT POSITIONS

1. National Legal Advisor – One Position

<u>Main Responsibilities</u>: Provide legal advice and assistance to TIMOR GAP and its subsidiaries, upstream, downstream and Parent company units. He/she is required to assist and support TIMOR GAP subsidiaries in negotiating commercial agreements and JOAs with potential partners. The national legal advisor is required to have a thorough understanding on Petroleum tax law, petroleum activity law, Labor Law, commercial law and all other laws and regulations relevant to TIMOR GAP operations.

2. International Legal Advisor – One Position

<u>Main Responsibilities</u>: Provide expert legal advice and guidance to the company, draft and review all types of agreements, including MOUs, letter of engagement, service agreements, fuel supply agreements, sales and purchase agreements, employment agreements, commercial agreements, Farm-Up agreements, joint-operating agreements (JOAs) and production sharing contracts (PSCs). The international legal advisor is required to provide legal support to TIMOR GAP subsidiaries in the PSC application process and PSC negotiations with the ANP and relevant Ministries.
